The Prison Rape Elimination Act (PREA)

The Bowie County/Bi State Detention Centers have established a zero-tolerance policy towards all forms of Sexual Abuse and Sexual Harassment. The Detention Centers will comply with required regulations that fall within the scope of the Prison Rape Elimination Act (PREA) and the DOJ National Standards to Prevent, Detect, and Respond to Prison Rape (Final Rule, dated June 2012) or Subpart A of the Homeland Security Standards to Prevent, Detect and Respond to Sexual Abuse and Sexual Assault in Confinement Facilities (79 Fed. Reg.13100 dated March 7, 2014).

It is the responsibility of every Bowie County Detention employee, volunteer, or contractor to immediately report any information passed to them by an inmate, employee, volunteer, contractor, third party, or anonymously regarding sexual abuse and assault whether the allegation is against an employee, another inmate, volunteer, or contractor. This will include any verbal or written reports of retaliation by other inmates or employee for reporting sexual abuse and sexual harassment, as well as staff neglect or violation of responsibilities that may have contributed to such incident. The Detention Center staff will promptly document any verbal reports of sexual harassment, touching, or other sexual act, even if the allegation may have occurred at another facility. Aside from reporting this information to a designated supervisor or official, Bowie Detention staff will not share information related to a sexual abuse report than to the extent necessary, as specified in detention policy, for treatment, investigation or security and management positions.

Reporting Allegations of Sexual Abuse/Assault/Harassment

Anyone can report an allegation or suspected incident of sexual abuse, assault, or sexual Harassment, including inmates, staff, or third parties. This can include allegations that may have occurred at another facility of confinement, supervision, or treatment. Allegations of sexual abuse, assault, or harassment may be reported by the following methods:
