An election is hereby ordered to be held in the City of Texarkana, Texas, at the respective voting places determined and set by Bowie County, Texas, on the **5th day of November, 2024**, for the purpose of voting for a Mayor, a Councilmember for Ward One (1) and a Councilmember for Ward Two (2) of the City of Texarkana, Texas.

Candidates for Mayor shall be voted on only by the qualified voters residing in the city limits of Texarkana, Texas. Candidates for councilmembers of Ward One (1) and Ward Two (2), respectively, shall be voted on only by the qualified voters residing in the ward from which the candidate seeks election.




Applications for Ballots by Mail (ABBM)s must be received no later than 5:00 p.m. on **October 25, 2024**, in the Bowie County Elections Office.
