

**IN THE COMMISSIONERS COURT
OF
BOWIE COUNTY, TEXAS
ORDER REVISING ELECTION PRECINCTS**

BE IT REMEMBERED, that on the ____ day of July, 2026, the Commissioners Court of Bowie County, Texas, adopted revised boundaries for certain of its Election precincts, pursuant to Chapter 42 of the Texas Election Code, including but not limited to sections 42.005, 42.006 and 42.031(b)(1).

WHEREAS, during the 89th Legislature, 2nd Called Session, the Texas Legislature approved House Bill 4 relating to the composition of the districts for the election of members of the United States House of Representatives from the State of Texas, CONGRESSIONAL DISTRICTS – PLANC2333. This legislation was approved by the Texas Senate and the House of Representatives and signed into law by the Governor on August 29, 2025.

WHEREAS, the 89th Legislature, 2nd Called Session, adjourned on September 4, 2025.

WHEREAS, House Bill 4 did not receive a vote of two-thirds of all members elected to each house; therefore, House Bill 4, the composition of the districts for the election of members of the United States House of Representatives from the State of Texas, CONGRESSIONAL DISTRICTS – PLANC2333, became effective on the 91st day after the last day of the legislative session, December 4, 2025.

WHEREAS, the recent realignment of the composition of the congressional districts has rendered unnecessary and inefficient certain election precincts in Bowie County; requiring merger of certain election precincts to meet the minimum requirements of Section 42.006, Election Code.

WHEREAS, pursuant to the provisions of Chapter 42, Texas Election Code, the Commissioners Court hereby approves the merger and realignment of the following County Election Precincts to contain at least 100 but not more than 5,000 registered voters while meeting the requirements of Section 42.005, Election Code and Section 42.0051, Election Code.:

Election Precincts to be Merged
22A into 22
20A into 20
18A into 18
14A into 14
12A into 12
11A into 11
9A into 9
13A into 9
5B into 4A

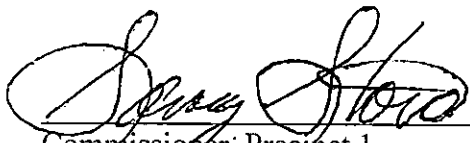
NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

The above and foregoing changes to Election Precincts shall take effect immediately, and will remain in effect until changed by further Order of this Commissioners Court.

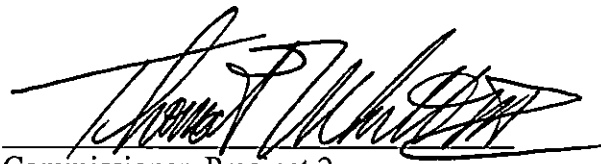

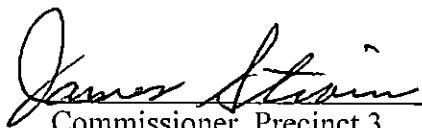

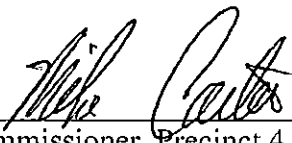
Commissioner, Precinct 1



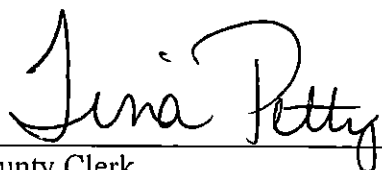
Commissioner, Precinct 2



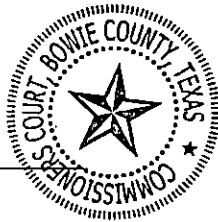
Commissioner, Precinct 3

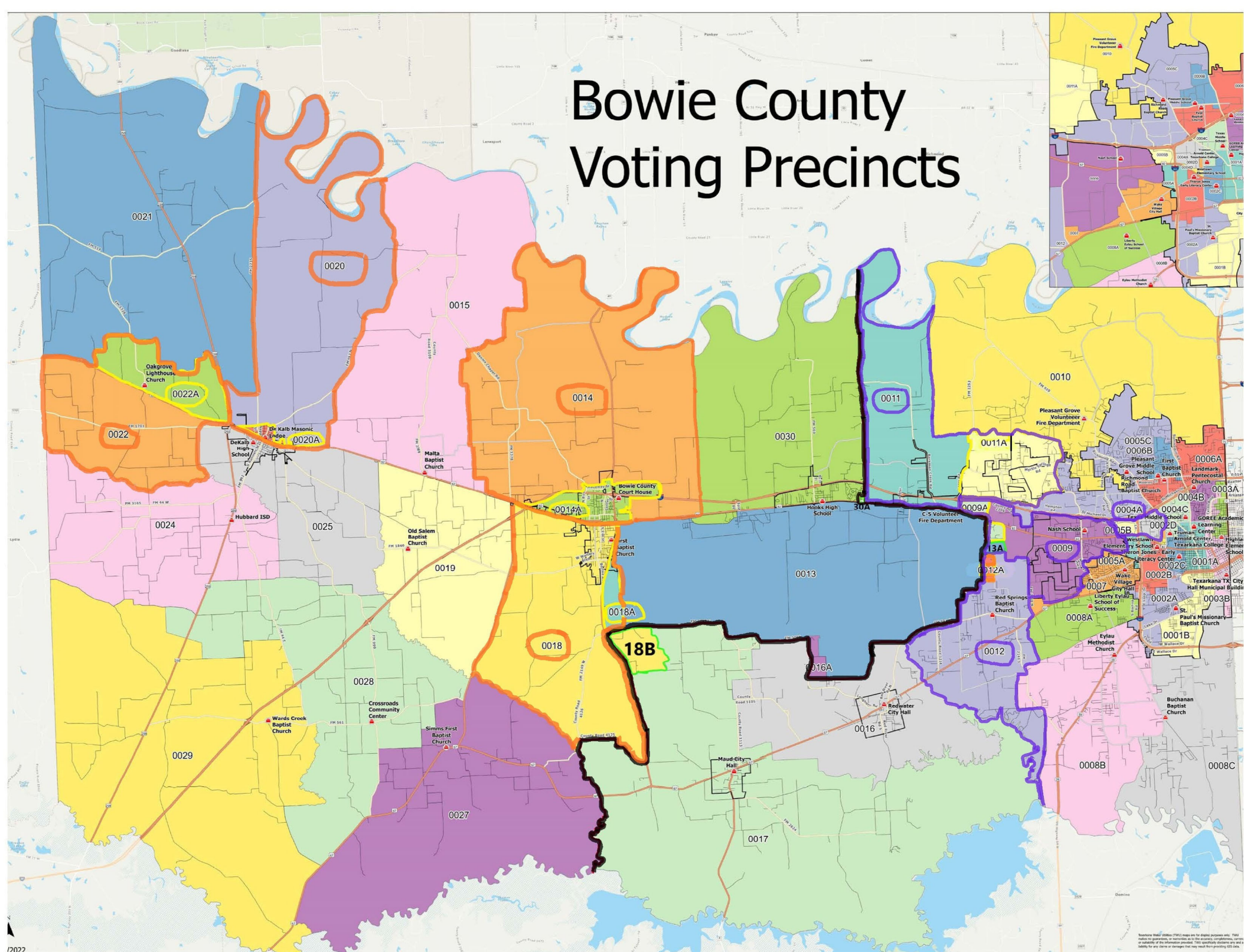
