  - 1. Public Comments public comments shall be limited to 3 minutes per presenter who submitted a public participation form at least 15 minutes before the start of the meeting. Comments must be pertinent to an agenda item or an area for which the Court has jurisdiction. The total allocated time is 30 minutes for all comments.
