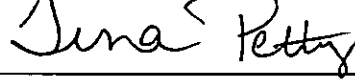
Call to Order.

1. Public Comments – public comments shall be limited to 3 minutes per presenter who submitted a public participation form at least 15 minutes before the start of the meeting. Comments must be pertinent to an agenda item or an area for which the Court has jurisdiction. The total allocated time is 30 minutes for all comments.
2. Commissioners Court response to public comments.
3. Consider and take action to revise Bowie County Election Precincts as necessary to comply with the changes in Congressional District boundaries under H.B. 4, Second Called Session, 89th Texas Legislature.
4. Consider and take action to approve the following Intercounty and External Contracts for Bowie County Juvenile Probation for September 1, 2025 through August 31, 2026: Angelina County, Bell County, Bexar County, Dallas County, Denton County, Garza County, Grayson County, Gregg County, Guadalupe County, Harrison County, Hays County, Lubbock County, Midland County, Montgomery County, Randall County, Smith County, Taylor County, Tom Green County, Van Zandt County, and Victoria County, Youth-Opportunities-Rockdale, Gulf Coast Trade Center, Pegasus Schools, Inc., and Rite of Passage.

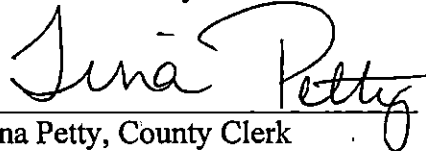
