

****PAYMENT NOTICE****

Justice Court Precinct 2 Place 1 Online Payments

BEFORE MAKING A PAYMENT VIA CREDIT CARD YOU MUST FIRST CALL THE COURT TO GET ALL REQUIRED INFORMATION FOR PROPER PROCESSING OF YOUR PAYMENT. PLEASE ALSO REVIEW YOUR CITATION TO MAKE SURE YOU ARE CONTACTING THE CORRECT JUSTICE COURT.

PLEASE READ THE FOLLOWING CAREFULLY. SHOULD YOU HAVE ANY QUESTIONS PLEASE CONTACT THE COURT CLERK 903-628-6812.

Texas Code of Criminal Procedure, Article 27.14 (c) states:

"In a misdemeanor case for which the maximum possible punishment is by fine only, payment of a fine or an amount accepted by the court constitutes a finding of guilty in open court as though a plea of nolo contendere had been entered by the defendant and constitutes a waiver of a jury trial in writing."

- Payment in full by the defendant constitutes a plea of nolo contendere (No Contest).
- Online payment options are only available for ADULT (18+) DEFENDANTS ONLY.
- All juvenile defendants under age 17 and minors over age 17 charged with alcohol and tobacco offenses must make a personal appearance in Court with a parent or legal guardian.
- The Court **WILL NOT** accept payment from a third party without a plea in writing from the defendant. A plea form is available under "criminal case forms" on the JP2 website.
- The Court will only accept a partial payment once a plea form and payment plan application has been submitted and accepted by the Court. Once the Court has received the required documents, the Judge will review the payment plan application and issue a signed Time Payment Order that will be mailed and/or emailed directly to the defendant.
- If the defendant would like to request Driver Safety Course (Defensive Driving) or Deferred Disposition for the citation, you will need to contact the Court **BEFORE** making a payment online.
- If defendant has previously entered a plea of NOT GUILTY and defendant would like to pay the fine instead, you **MUST** contact the Court.
- If paying the fine after business hours and have an active warrant on your case, the warrant will not be recalled until the next business day.

TO CONTINUE WITH AN ONLINE PAYMENT, YOU ACKNOWLEDGE TO HAVE READ THE POINTS LISTED ABOVE AND THAT YOU HAVE PROVIDED THE COURT WITH TRUE AND CORRECT INFORMATION. FAILURE TO COMPLY MAY RESULT IN A DELAY PROCESSING YOUR PAYMENT ON YOUR CASE.

BY CLICKING THE LINK BELOW, YOU WILL BE REDIRECTED TO CERTIFIED PAYMENTS. THERE WILL AN ADDITIONAL 2.85% CONVIENCE FEE CHARGED TO THE CARD HOLDER.
